### MEMORANDUM OF UNDERSTANDING (MoU) BY AND BETWEEN

#### **RABIN MUKHERJEE COLLEGE** Kazi Para Rd, Dhopapara, Parnasree Palli, Behala, Kolkata 700060, West Bengal, India

This Memorandum of Understanding (MoU) is made on 17 June 2022 between Vivekananda College and Rabin Mukherjee College for mutual cooperation witnesseth in academic exchanges, program development and research. This document establishes the guiding terms and principles of collaboration between the two organisations:

## Legal Frameworks of Both the Organizations

Vivekananda College, established in 1950, is a postgraduate college, affiliated with the University of Calcutta and recognized by the UGC U/S 2f and 12B, has its campus at 269, Diamond Harbour Road, Thakurpukur, Kolkata-700063, West Bengal, India. The college admits students irrespective of caste, creed and religion and teaches through the medium of English and Bengali according to the syllabus laid by the University of Calcutta. It is represented by its Principal, Dr. Tapan Kumar Poddar, hereinafter referred to as the FIRST PARTY (which term or expression shall, unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assigns). Both these organizations will hereafter be referred to as Parties.

Rabin Mukherjee College, formerly Behala College of Commerce was established in 1967 at Parnasree, Behala, Kolkata-700060. In the year 2005 Behala College of Commerce was renamed as Rabin Mukherjee College is an undergraduate college, affiliated with the University of Calcutta and recognized by the UGC U/S 2f and 12B, has it campus at Behala, Kolkata 700060, West Bengal, India. The institution is known for its degree level education of Arts, Science and Commerce discipline. It is represented by its Principal, Dr. Sreekumar Ray, hereinafter referred to as the SECOND PARTY (which term or expression shall, unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assigns). Both these organizations will hereafter be referred to as Parties.

#### Purpose of the Agreement 11.

Both the Parties are pleased to enter into an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions through the following, but not limited to:

- Joint teaching and research projects. 1.
- Collaboration in the area of academic publications, research activities, field trips, etc. 2.
- Visits, training, and exchange of faculty, staff, and students. 3.
- Joint educational/vocational courses. 4.
- Joint consultancy, PhD supervision, scientific publications. 5
- Co-hosting and participation in conferences, seminars, symposiums, and workshops. 6.
- Social and cultural programs. 7.
- Any other academic activity that is mutually agreed upon and is beneficial to both. 8.

### **Execution of the Agreement**

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, the period the sub-agreement will be in effect, and administrative responsibility within each institution.

### Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of five years. After these five years, it will be mutually extended for the same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination, and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination, or expiration unless otherwise agreed upon between the Parties.

Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

#### NON-EXCLUSIVITY:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third

- There will be no financial involvement by either of the parties.
